TRADING STATEMENT

In accordance with the Lusaka Securities Exchange (“LuSE”) Listings Requirements, the Board of Directors of British American Tobacco Zambia PLC (“BATZ” or “the Company”) hereby advises the Shareholders of the Company that the Earnings Per Share and Headline Earnings Per Share for the half-year ended 30th June 2018 are expected to be at least 1000% better than that for the half-year ended 30th June 2017.

The movement in profitability is mainly attributed to the 58% increase in sales volume for the six months under review facilitated by our ability to price more competitively with the preferential excise regime for local manufacturers.

Shareholders are advised that the information contained in this Trading Statement has not been reviewed nor reported on by the external auditors of the Company.

The Company expects its results for the half-year ended 30th June 2018 to be released on SENS on or about 3rd August 2018. Accordingly, shareholders are advised to exercise caution when dealing in the Company’s securities until publication of the results.
