Introduction

At the Annual General Meeting of Prima Reinsurance PLC (“Prima Re” or “The Company”), held on 30th April 2020 (the “AGM”), the following special resolution was duly passed by Prima Re shareholders:

1. **RESOLVED** Prima Re will change its name to Zambia Reinsurance PLC (“ZAMBIA RE”).

Registration with the Patents and Companies Registration Agency (“PACRA”)

The new name of the Company, Zambia Reinsurance PLC, has been registered with PACRA as of 31st July, 2020.

Effective Date of the change of name on the LuSE

The new name will come into effect on the LuSE on Monday, 15th February, 2021.

Abbreviated name of the Company on the LuSE (stock code)

On the LuSE Automated Trading System (“ATS”), the company will trade under the new stock code of (“ZAMBIA RE”) from Monday 15 February 2021.
