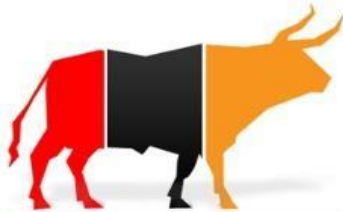
The Board would like to thank Mr. Wanjelani for the immeasurable service he rendered to the Board. The Board wishes him the best in his future endeavours.
