TRADING STATEMENT

In accordance with the Lusaka Securities Exchange ("LuSE") Listings Requirements, the Board of Directors of ZAMBREW (the "Company") hereby advises the Shareholders of the Company that it expects to report a negative Earnings (Loss) per Share (EPS) for the financial year ended 31st December 2023, down 641% compared with the positive EPS for the financial full year ended 31st December 2022.

The performance for the period ended 31st December 2023 has been impacted by an increase in the price of raw materials and other consumables due to a significant weakening of the kwacha in the second half of the year, along with an increase in finance costs related to the Company's Lusaka plant expansion project.

Shareholders are advised that the information contained in this Trading Statement has not been reviewed nor reported on by the external auditors of the Company.

The Company expects its results for the financial year ended 31st December 2023 to be released on SENS and published in the local press on or about 2nd April 2024. Accordingly, shareholders are advised to exercise caution when dealing in the Company's Securities until publication of the results.
